Such changes shall be incorporated into the Plans and Project Manual and shall apply to work with the same meaning and force as if they had been included in the original Plans and Project Manual. Where this Addendum modifies a portion of a paragraph or phrase of the Project Manual, the remaining unmodified portion of the paragraph or phrase shall remain in force.

The conditions and terms of the Plans and Project Manual shall govern work described in this Addendum. Whenever the conditions of work, or the quality or quantity of materials or workmanship are not fully described in this Addendum, the conditions of work etc. included in the Plans and Project Manual for similar items of work shall apply to the work described in this Addendum. If no similar items of work are included in the Plans and Project Manual, the quality of material and workmanship shall be subject to the written acceptance of the Architect.

1.6 This is a Prevailing Wage Rate Project. Rates can be found in the Project Manual, Specification 00820.

1.7 <u>Project Overview</u>

The work will be performed under a Single Prime Contract and consists of the removal and salvage of approximately 76 existing windows. The openings will be re-prepped, including installation of new sills with end-dams, re-flashing, and re-caulking. The windows will be reinstalled and tested. Required work will also include patching and repairing of gypsum board and replacement of window stool. Owner will be responsible for moving furniture, equipment and window treatments.

1.8 <u>Alternates</u>

Alternate #1 – Seven (7) windows on the West elevation as selected by the Owner will be removed, the openings re-prepped and the windows reinstalled.

Alternate #1A – Twenty (20) windows (includes seven (7) windows in Alternate #1) on the West elevation will be removed, the openings re-prepped, and the windows reinstalled.

Alternate #2 – Contractor will engage a qualified independent test and inspection agency to perform leakage tests per AAMA 502-08 specifications at 6.24 psf. Six (6) windows selected by the Owner will be tested. If evidence of water penetration is present on more than two (2) windows, the Contractor will perform additional tests at no expense to the Owner.

1.9 Phasing

<u>Phase 1 (19 windows)</u> – Work must begin on the North Elevation on the second floor on the easternmost window denoted on drawings as Phase 1, and progress west. It is the intent of the Owner to have each interior room completed, including the windows on the west elevation, before progressing to the next room. Phase 1 must be completed by May 18, 2013.

<u>Phase 2 (26 windows)</u> – Work must begin on the North Elevation on the second floor on the westernmost window denoted on the drawings as Phase 2, and progress east. Upon completion of the second floor, work on the third floor may commence with the easternmost window and progress west.

Work on remaining windows under the Base Bid (12 windows) may be completed in a sequence determined by the Contractor.

If either of the Alternates is selected, the Contractor must coordinate with, and provide a schedule to, the Owner prior to initiating the work. Unless otherwise directed, the windows in either of the Alternate scopes will be performed after the Base Bid work is complete. The

Contractor must notify and receive written approval for any deviation from the above schedule prior to commencing work

1.10 A site tour was conducted after the meeting.
