2. What is the CARE Center?

The Consultation, Advocacy, Referrals and Empowerment (CARE) Center officially launches today, Sept. 16. It functions as a single stop to address non-academic student needs, including child care, food and housing, mental health, transportation and more.

Dedicated staff in the CARE Center connect students to resources and services available at the College or within the community. This service is free to all HACC students.

3. What are additional reasons that HACC decided to continue with remote and virtual instruction and services for the spring 2021 semester?

We recently learned the following:

- There is a rise of COVID-19 cases among individuals aged 20-29.
- The vast majority of people transmitting the virus are completely asymptomatic. For example, if an organization has two positive cases, they probably actually have 20 positive cases.

We do not want to follow the models of other institutions of higher education, where an outbreak occurs on campus, students transition to remote learning and the administration then tells students to go home.

4. What is the job description for the position of associate provost of academic affairs?

The associate provost of academic affairs oversees the Department of Curriculum and Assessment; Department of High School and Transfer Partnerships; Department of Library Faculty; and the Honors, General Studies and Study Abroad programs. The position also continues to serve as the lead for transfer articulation agreements, general education waiver/substitution requests, the College catalog and the academic calendar.

5. Can full-time faculty request an assignment of up to 21 credits of workload for the spring 2021 semester?

Full-time faculty may request a total workload of up to 21 credits. This includes teaching and planning, preparation and assessment (PPAs) for winter session and spring 2021 semester classes.

We initially limited faculty to an assignment of up to 18 credits to allow flexibility when adjunct faculty pulled out at the last minute or when we needed to add sections of popular classes and had a limited number of qualified faculty. However, that resulted in some faculty being assigned up to 21 credits while others were held to 18 credits. We will allow faculty to sign up for a total workload of up to 21 credits for spring 2021 and assess the results. Is the College going to withhold employees' share of social security taxes? I hope not, although I realize the decision is not for the employees to make. I do not want to deplete my social security funds, and I don't want to have deferred social security payments deducted from my paycheck at a later date.

Given that the program is a temporary deferral of taxes and may place potential hardship on employees by reducing their paychecks later to repay the deferral, the College will not be participating in the voluntary program.

The IRS recently released guidance to implement a presidential memorandum directing the secretary of the treasury "to defer the withholding, deposit, and payment" of the employee share of social security taxes on wages paid between Sept. 1 and Dec. 31, 2020 [Notice 2020-65, 8-28-20].

The memorandum provides employers the option to voluntarily defer the employee share of social security tax on applicable wages between Sept. 1 and Dec. 31, 2020. The employer would then withhold the deferred amount from the employees' wages between Jan. 1 and April 30, 2021. If the employer does not withhold and remit the employee portion of the tax by April 30, 2021, they face interest and penalties charges.
