- 1. I’m a current nursing student, and I missed the Zoom session held last week. Where can I get that information?**

The Nursing Department held an information session to update students on the plans for fall 2020. Current students in programs who are returning this fall were given an opportunity to hear the plan and ask questions. [Please click this link](#) if you

We recognize the burden that uncertainty places on all of you. Please be patient as we await finalized information from our clinical facility partners regarding restrictions. Our tentative goal is to have clinical schedules in place by the week of July 13. Please understand that these plans are fluid. Therefore, this time period is tentative and subject to change.

For new students who were accepted into the nursing clinical section to start this fall, your orientation day Zoom session will provide more specific information. Details on that orientation will be included in the admission packet sent to your HAWKmail account.

**2. I am graduating this fall. Has a decision been made about the December Commencement ceremony?**

We understand the importance of celebrating the remarkable achievements of our graduates. Due to the uncertainty associated with the global pandemic, HACC is determining next steps to ensure our graduates are celebrated while abiding by state guidelines. **3. What if a student has a medical condition that prevents them from wearing a mask on campus? Will they still be allowed on campus?**

If a student has a medical condition that prevents them from wearing a mask, they will not be permitted to come on campus. Instead, we will ask them to work with their instructor to see if they should postpone course completion or work on an alternate assignment.

**4. Where can I learn more on how to make the most of my personal emergency funds?**

**5. I heard that the U.S. Department of Homeland Security (DHS) has banned international students from attending colleges in the United States where the**

**programs are entirely online.**

HACC's programs are being offered this fall 2020 in a hybrid model, which is an exception to the DHS ban. As noted in [Inside Higher Ed](#): International students may remain enrolled at HACC as long as "the program is not entirely online [and] that the student is not taking an entirely online course load for the fall 2020 semester."

**6. I'm scheduled to take Anatomy and Physiology in the fall. Will it be on campus, or will it be remote?**

Anatomy and Physiology (BIOL 121 and 122) will be offered remotely this fall 2020 semester. We are working to update the location of the building to be listed in the class schedule as "remote."

**7. When will the Online Learning Commons website be released and how can I access it?**
